Disclaimer, Waiver of Liability, Assumption of Risk, and Indemnity Agreement

Absences: If absence is known in advance, contact the TBEY; call 414.562.TBEY(8239) as soon as possible.

Privacy: TBEY Arts Center, Inc.'s employees and volunteers are required to handle delicate information about students/members and student's/members parent(s)/guardian(s). Volunteers are aware that some information from students/members or the students/member's parent(s)/guardian(s) are confidential. No information is given out unless specified by the student's/members parent(s)/guardian(s).

Emergency: In case of an emergency, follow the emergency procedures of the assigned location. Also, be familiar with emergency exits of the facility. Dial 911 as soon as possible. Students & parents must fill-out emergency contact on registration form.

Dress Code: Clothing promoting drugs, alcohol, and tobacco products, or their use, is discouraged. Clothing should be appropriate for the task.

Cell Phones: No use of cell phones during rehearsal or performance time.

Drug/ Alcohol: Use, possession, distribution, or being under the influence of drugs or alcohol will not be tolerated.

Discrimination: TBEY Arts Center, Inc. intends to fully comply with all state, federal, county and municipal laws as understood and applied by the Courts which prohibits negative discrimination because of race, disability, color, creed, religion, gender, age, sexual orientation, marital status, national origin, ancestry, citizenship, military status, or other protected classification.

Weapons: Any item that's intended use is to cause injury to a person is not allowed on at the assigned location.

Violence: Violence will not be tolerated. Any act of violence or threat of violence calls for immediate dismissal of the team.

Personal Property: TBEY Arts Center, Inc. is not responsible for lost, stolen or damaged items.

Dismissal: TBEY Arts Center, Inc. reserves the right to dismiss any students/members without notice, but reason will be clearly stated.

Liability: Participants are to release, indemnify and hold harmless TBEY Arts Center, Inc., its sponsors, directors, officers, employees and supervisors of all activities, from the negligence of TBEY Arts Center, Inc., otherwise, in conjunction with participants' events and activities. TBEY Arts Center, Inc. cannot be held liable for any injury to the students/members that occurs at any time while performing or participating in program activities for TBEY Arts Center, Inc. either on the premises of TBEY Arts Center, Inc. at assigned locations, off-site events, or while traveling to or from such locations and events of TBEY Arts Center, Inc.

Waiver: In consideration of permission to use, today and on all future dates, the property, facilities, staff, equipment and services of TBEY Arts Center, Inc., I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue TBEY Arts Center, Inc. D.B.A TBEY Arts Center, Inc., its directors, officers, employees, and agents from liability from any and all claims including the negligence of TBEY, Inc., resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in activities, classes, observation, and use of facilities, premises, or equipment.

Assumption of Risks: Physical activity, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. TBEY, Inc. has facilities for and provides for dance, theatre, music and visual arts activities. Some of these involve strenuous exertions of strength using various muscle groups, some involve quick movements involving speed and change of direction, and others involve sustained physical activity which places stress on the cardiovascular system.

The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains to 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the activities made possible by TBEY, Inc. I hereby assert that my/child participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD TBEY, Inc. HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement at the TBEY Arts Center, Inc. and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of Wisconsin and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
